





## **Wedding Photography Contract**

#### **Services Provided:**

Ammaniel Hintza Photography agrees to provide photography services for the wedding clients on the date mentioned above. This includes coverage of the ceremony, reception, and other specified events.

Saturday Weddings: Photography coverage will begin at 7:00 AM Sunday Weddings: Photography coverage will begin at 5:00 PM

## **Payment Terms:**

The total cost for the wedding photography services is mentioned above. Payment shall be made in installments as follows:

**First payment: 50%** due today, upon signing this contract, which is non-refundable. **Last payment: 50%** due one month before the first event. Late payments may incur a late fee charge.

#### **Pricing and Discounts:**

The standard price for one-day coverage is \$3890, and for two-day coverage, the price is \$5990. If any discount or special offer is applied, please note that the **album** and **canvas** prints will not be included in the package. These items can be added separately at an additional cost.









## **Travel Arrangements:**

The client is responsible for providing transportation tickets, booking a hotel room, and arranging for a rental car for the photographer during the wedding events. The client agrees to book the same hotel where the photographer will be accommodated to facilitate smooth coordination for efficient coverage of the wedding. The client agrees to reimburse the photographer for gas and parking expenses incurred during travel to and from the wedding venue.

#### **Photo Delivery:**

Ammaniel Hintza Photography will deliver edited high-resolution digital images within 4 weeks after the wedding date. The final edited images delivered by the photographer represent the completed work in high-resolution JPG format, and no raw or unedited files will be provided to the clients.

#### **Usage Rights:**

Ammaniel Hintza Photography retains copyright ownership of all images. Wedding clients are granted personal usage rights to print, share, and display the images for non-commercial purposes.

Ammaniel Hintza Photography may use selected images for promotional purposes unless otherwise specified in writing by wedding clients. The selection of specific images for such purposes is at the sole discretion of the photographer.









## **Photo Editing:**

The photographer will provide basic editing and retouching of images. Please note that not every photo taken will be edited and delivered. Any photo session on the list of desired shots provided by the client will be included for editing. Additional editing requests may be subject to additional charges as outlined in the pricing agreement.

## **Photographer Priority:**

The client agrees that the photographer shall have priority over the videographer during all wedding events and sessions. The photographer will have the primary right to position and capture shots before the videographer.

#### **Client Cooperation:**

The client agrees to provide a list of desired shots, including specific family groups to be photographed. The client must order canvas prints and album services within 1 month after the wedding. If the session is shortened due to the client's lateness or delays, the photographer is not responsible for missed moments, and no refunds or extensions will be provided. The shooting time for the wedding session is set to 2 hours.

#### **Wedding organizer & Makeup Artists:**

The wedding couple is required to hire a wedding organizer to ensure seamless coordination throughout the day. Additionally, if there are more than two bridesmaids, extra makeup artists should be arranged to ensure everything stays on schedule.









## **Photographer's Presence:**

The photographer will dress professionally and conduct himself appropriately. A meal, including a vegetarian option, should be provided. The photographer will take a 1-hour break during the event.

## **Working Hours:**

The photographer's services will not extend beyond 12:30 AM under any circumstances unless previously agreed upon in writing.

#### **Pre-Wedding Session:**

If the couple wishes to include a pre-wedding session, which is highly recommended, it will be offered at an additional cost of \$500. This session can be scheduled on a separate day prior to the wedding and will provide the couple with a set of beautifully captured images to commemorate their wedding.

#### **Hotel Sessions:**

Photography sessions at the hotel are reserved exclusively for the couple and their wedding party. Family sessions will only take place at the ceremony or reception venue.









#### **Session Priorities:**

- 1. The couple First priority for all sessions.
- 2. Bridal party Second priority.
- 3. Family Family sessions at the ceremony or reception venue only.

## **Outfit and Makeup Changes:**

Multiple outfit or makeup changes reduce photo time. It's recommended to stick with one look for an efficient session.

## **Force Majeure:**

In the event of unforeseen circumstances like natural disasters, the photographer will make reasonable efforts to fulfill the contract but shall not be held liable.

## **Governing Law:**

This contract is governed by the laws of Texas, USA. Any disputes shall be resolved in Dallas County courts.
